## Message from the Chairman Fundraising Committee



Dear Fellow Doscogs,

It gives me great pleasure to be writing to you in my capacity as Chair of the newly constituted

Fundraising Committee of the Board of Governors.

The first question that you are all going to ask is – “Why does the school need a Fundraising Committee given that the finances appear to be in much better shape than they were some years ago?”

This is a very good question. Thanks to the great efforts of outgoing Chairman Gautam Thapar and other members of the Board of Governors, notably Mr Indresh Narain, the School's finances are now on a much sounder footing. There is now a clear understanding of the requirement to balance the books on an operational basis. This has been done – and it is worth noting that for the education the school provides, our fees are still extremely competitive with other Indian schools that have similar educational aspirations. I am bound to say that we do not charge any premium for the unique and priceless education that Doon provides and for which my brothers, my cousins, I, and I am sure all of you, will be forever grateful.

Why then the need for money? One of the best things I learned in Doon was that it was never enough to rest on one's laurels. The striving for continual improvement, of trying to be the best that one can be, of setting higher standards for oneself is a key element of being a Dosco. It is also a key element of the School's philosophy. Although we have had great success in maintaining our status as one of the pre-eminent global schools we can and should do much more. In this, we will

need to rely on your generosity – and it is fitting that we ask you to contribute to preserve the pre-eminence of the School that gave us so much to be thankful for.

There is no shortage of very good uses for your money. You will have seen the many improvements in Chandbagh over the last few years, ranging from the much-needed improvements in the physical infrastructure on campus, including the new classrooms and much improved teacher accommodation. Work on upgrading the Houses has already commenced and should be completed over the next couple of years. But there is still an urgent need for funds that must come from sources other than fee income.

- (i) The School is lacking a world class indoor Sports Centre. Given how important sport and physical education are in the School's ethos, and the importance of “mens sana in corpore sano” which is how the ancient Roman poet Juvenal prayed for a healthy mind in healthy body, this is something that needs to be addressed very soon. Many Doscogs are now turning to professional sport as a viable career aspiration – and this will occur increasingly in the future – and it would be remiss of us not to acknowledge this dramatic change in possibilities for future generations of Doscogs.
- (ii) Very little public funding remains for enabling able boys to come to The Doon School if they cannot afford the fees. My dream is that we, like Harvard (with whose network Doscogs are often compared), should operate a fully needs blind admissions policy, such that no boy who has the potential to be a Dosco is denied admission because his parents cannot afford the fees
- (iii) As with sport, a whole world of possibility awaits the truly talented in the media and cultural industries. From games programmers to the

creators of virtual reality worlds, the need for creativity and “out of the box” thinking are increasingly important. The school urgently needs a world class Science and Technology Complex and also a world class Performing Arts Complex so that future generations of Doscogs can continue to excel in these fields.

You will all be hearing from us as we attempt to enlist your support for these bold endeavours as and when the Board has approved them. Along with our DSOBS Fundraising partners we will be continuing to approach you to see in what ways you might wish to contribute to School. Whether it is participating in the many campaigns that DSOBS will run in raising money for the School, or engaging with one of my partners on the Board Fundraising Committee for the larger donations, we promise to make the process as easy and as fulfilling as possible.

With all of our donors we promise that (i) we will make it clear what your funds will be used for (ii) we will provide you with a full rationale for all the fundraising needs and (iii) crucially, we will continue to provide you with regular updates on the improvements to School and the great increase in the aspirations and achievements of future generations of Doscogs that your generosity will enable.

I look forward very much to working with all of you in my second term on the Board of Governors under the Chairmanship of Mr Sunil Munjal. I hope we can appeal to your generosity to take The Doon School to ever greater heights.

# Chandbagh

## Message from the Head Master



It has been almost 15 months since I left Germany to move to India and The Doon School. When looking for a new school as a Head, nothing matters more than the quality and operation of the Board of Governors.

I had been looking for a not-for-profit school with a Board made up of volunteers with passion and capacity, free of the personal interest that one often finds on elected or parent led boards. What I found is a Board which is a model for school governance that any school in the world could learn from.

A Board like this exists when it is carefully and thoughtfully led by a Chairman whose values are aligned with the values of service to others before self and of meritocracy above nepotism.

The relationship between a head and the chair of the board is a special one and the health of the institution depends very much on the health of that relationship. In Gautam, I have had a mentor and a cultural guide since we met in early 2016. His clarity, insight and wisdom have been a source of learning like no other. Coupled with his humour, un-wavering love for

school and deep understanding of the Dosco psyche, my orientation to Doon has been all that I could have hoped for.

It was also important to me that the board had a system of governance in place that allowed it to be independent of personalities. In terms of making things happen, the committees of the board are dynamos for the school.

The CDC, under the leadership of Sumanjit, has managed more school infrastructure improvements in one year than I have seen in five at most schools. The level of input, trust and contribution from all of the members of the CDC is inspirational. Achievements include the completion of the masters' housing and the complete renovation of the traditional bench and table teaching spaces into smart 21st century classrooms which make for world class learning and teaching.

The TAC, under the watchful eye of Indresh, makes sure that we are using the income from fees and donations for the benefit of the boys in the most sensible and economic way. The committee also works to insure that we find the funding for things that allow us to exercise our imagination and innovation in pedagogy, service, sport, adventure and activities to keep the school current, relevant and adaptable.

The Education Committee, chaired by Shashank, is a sounding board and an advisory group for me to bounce ideas off

and to help us think more broadly than the day-to-day of running a school sometimes allows. This committee is a true complement to the 74 teachers working at Chandbagh.

The Scholarship and Bursary Committee, chaired by Deepak, ensures that we are able to live up to our promise to find and develop boys from all backgrounds. With more than 5 Cr. to disburse in financial aid the committee asks the questions that help get the bursaries to the boys who need it and support our efforts to bring in geographical, economic and social diversity.

Over the past months, I have also enjoyed working with and learning from the DSOBS, particularly with its president, Bull. A more committed, passionate, school-focused advocate for the boys past, present and future, I have never come across. I'm delighted that the school, IPSS and the DSOBS have a working relationship that is communicative and mutually supportive.

It is wonderful to see that the DSOBS exemplifies aristocracy of service to society at all levels.

In this sense the circle is complete; we have a mission, a board, a staff, a body of students and a society of old boys who work together, live together and learn together to serve a meritocratic India.

The well-crafted and balanced mix of Academics, Sports, Extra Curricular and Social activities, helped me build a sense of purpose, responsibility and stewardship, that not only allowed me to sail successfully through the Engineering & MBA days, but have also been a guiding force in shaping my professional career.



## DOSCENT Update

The Doon School English Charitable Trust Foundation (DOSCENT UK) - Scoring a blinder for a worthy cause.

School is particularly interested in providing merit based scholarships to those who may be unable to afford the fees, in line S.R. Das's vision of building a genuinely diverse school.

In line with this vision, DOSCENT UK, a regulated charitable trust was set up in 1983 by Late Gulab Ramchandani when he was HM to raise funds from old boys based in the UK.

DOSCENT UK was previously managed by senior Dosco Suresh Advani (149 J, Class of 1958) for 25 years. In March 2010, in agreement with School and in the President of DSOBS, Suresh handed over the role of managing trustee to Sharad Rathke (180 KA, Class of 1990) who is based in London. Shortly thereafter, Sharad invited Ravi Bulchandani (609 KA, 1979), another London resident to help him on the Board. Sharad and Ravi are joint managing trustees and member's of IPSS.

With dogged determination and perseverance over many strategy sessions and meetings, Sharad and Ravi (who also serves as a Member of the Board of Governors) successfully coalesced support from a number of old boys and friends in the UK and overseas, kickstarting the first UK Full Scholarship Programme by raising funds in excess of GBP 100,000 (INR 1 crore+). To see the programme go live which has begun to bear fruit has been gratifying for all stakeholders. This journey really started with meticulous planning and execution of the famous Summer Boat Party on River Thames, an event attended by almost 200 old boys and their families!

In addition to the generous support from donors, the Headmaster, on behalf of The Doon School and The Indian Public Schools' Society wishes to extend his warm thanks to outgoing Chairman Gautam Thapar, the UK DSOBS representatives Nimai Swarup (11 HA, Class of 1996) & Vivek Thadani (532 OB, Class of 1995) and the Development and Alumni Relations Office for coming together with the UK Trustees and changing the course of history. Boys selected under this programme may otherwise never have had the chance to be part of this exceptional institution and who knows what heights they might conquer one day...!

Looking ahead, we can and we must capitalise on this start if we truly wish to build a diverse school. The Trustees of DOSCENT UK are keen to espouse the spirit of diversity more widely by implementing multiple programmes and invite everyone in the fraternity to help make this endeavour a success.

They are raising the bar and are confident of crossing over with your kindness and support. Feel free to reach out to one of the UK trustees or Arjun Bartwal, your new Head of Development and Alumni Relations in Chandbagh.
