### Specifications for the supply of MUTTON & KEEMA - HALAL

- 1 The mutton legs shall be produced from healthy, disease- free and well-nourished goat that has been passed as fit for slaughter, by a veternity surgen of the health department and properly stamped by a slaughterhouse authority.
- 2 The weight of one mutton leg should not be more than 1.5 kg to 2 kg. It should be without saddle and tall bone, without hanging fat and skin tissues of other body parts.
- 3 Mutton leg should be cut into small pieces. Delivery should be in clean, hygienic and vaccum packed packets.
- 4 Packing should be clearly indicate date of packing and expiry.
- 5 For Keema, Mutton should be supplied without bones.
- 6 Supply to be made in refrigerated vam and there should be no break in the cold chain at any given point.
- 7 Coliform count should not exceed 2000/gm.
- 8 The colour of the flesh should be dark pink to red without any discolouration and parchments and without blood clots fractured bones.
- 9 The muscles should notinter mix with fat. It should be thickly muscled throughout in relation to their length.
